- Program begins January 4, 6, 8, 9 or 10, 2016 for 6 consecutive weeks.
- Deadline for registration with payment to BSA is December 20.
- Helmets are recommended, but not required.
- Coordinator receives a complimentary area ticket. One adult chaperone area ticket will be issued for every ten children.
- Transportation to and from the area is your responsibility.
- Sessions cannot be made up unless canceled by the ski area.
- List of chaperones and cell numbers for Ski Patrol.

Pre-season rental fittings are required for groups. The Competitive Edge is ready to serve you! Contact Jim Kennedy at the Competitive Edge by calling 413.538.7662. Jim will schedule a date & time for his crew to come to your site. This allows the Comp Edge to have your equipment ready upon your arrival each week.

Monday, Wednesday and Friday night groups can ski/ride the mountain anytime after 3:00pm until 9:00pm. 8:30am until 4:00pm for Saturday & Sunday groups.

Chaperones must escort children receiving lessons to the group's waiting area and remain until lesson begins. Have them work out a place to meet or check in after the lesson. Be sure your chaperones are aware of this.

Here is what the Snowsports Education Center MUST HAVE by the December 20 deadline:

- **2015-2016 Group Registration Form (see below) to be filled out by you.**
- **Master List/Spreadsheet that includes: Name, Skier or Snowboarder, Ability level, Helmet rental, Package Purchased, Totals (Level 1-first time or Level 2 or above-able to stop & turn)**
- **Complete 2015-2016 Refund Policy & Release of Liability Form for each participant (see below)**
- **Payment in full to the Blandford Ski Area**
- **Drop off or mail forms & payment to BSA, Attn: Snowsports Education Center, P.O. Box 159, Blandford, Ma 01008**

After the deadline of December 20, any changes or additions will be processed by the Snowsports Education Center. A parent who would like to register their child or change packages after the 20th can contact me directly. A late fee will be applied.

To be eligible for a refund, a written request must be received three days before the program’s start date. Once the program has started, no refunds will be granted. In some cases a credit may be issued depending on the circumstances to be decided by the director of the Snowsports Education Center. There will be an administrative fee of \$20.00. Please allow 8-10 weeks for the processing of refunds / credits.

I understand that Skiing and Snowboard skiing are hazardous activities, and I accept and clearly understand that there are inherent and other risks involved in the sport of skiing for which this pass is to be used. Those risks include, but are not limited to skier collision with padded and unpadded objects including natural and man-made objects or other skiers, varying terrain, weather conditions, ice, maintenance vehicles and many other hazards. I also understand that increased speed means increased danger and risk of injury. As a condition of being permitted to use the ski area premises, I freely accept and voluntarily ASSUME ALL THE RISKS of any injury or property damage, COVENANTS NOT TO SUE and RELEASE The Springfield Ski Club, Inc., its Board of Directors, employees and agents from any and all liability for personal injury or property damage resulting from negligence, conditions of the premises, operations of the ski area, actions or omissions employees or agents of the ski area or from my participation in skiing at the area, accepting myself the full responsibility for any and all such damage or injury of any kind which may result. I further agree to HOLD HARMLESS AND INDEMNIFY the above named persons or entity from any and all liability for death and/or personal injury, medical or other expense or property damage to myself or others resulting in any way from my use of the ski area premises. I further agree that (1) any claim, which I may at any time bring for any reason against The Springfield Ski Club, Inc., its Board of Directors, employees and agents, shall be submitted to the jurisdiction of the State of Federal Courts of the Commonwealth of Massachusetts and that no claims or actions shall be brought in any other jurisdiction; and (2) any claim shall be governed by the law of Massachusetts.
